



**67th Running Of
The Xpressbet Florida Derby
\$1,000,000 Guaranteed
(Grade I)**

THREE YEAR OLDS Nominations close Sunday, March 17. \$1,000,000 Guaranteed, plus a \$100,000 win-only bonus for registered Florida-bred starters and a \$100,000 win-only bonus for Florida Sire Stakes eligible starters. Any horse that has won a graded stakes or has participated in a race at Gulfstream Park will be charged no fee to enter. Any horse that has finished second, third, or fourth in a graded stakes shall pay a fee of \$2,500 to enter. All other horses shall pay a fee of \$5,000 to enter. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Starters to be named by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. All horses that are nominated or supplemented to the Xpressbet Florida Derby may be subject to out of competition testing prior to the running of the race. If more than 14 horses are entered, preference will be given to graded stakes winners, then by highest career earnings.
