THREE YEAR OLDS Free nomination by Sunday, February 17. \$1,500 to enter. \$150,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 120 lbs. Non-winners of a graded stakes on turf allowed 2 lbs., a stakes, 4 lbs., two races other than maiden, claiming, or starter 6 lbs. Starters to be named by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. Preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off turf, it may be subject to downgrading upon review of the Graded Stakes Committee.
