FILLIES AND MARES, FOUR YEARS OLD AND UPWARD Free nomination by Sunday, January 27. \$1,500 to enter. \$150,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over on turf since August 1 allowed 2 lbs.; a stakes race at a mile or over on turf since August 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. Preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner.
